

AUDL MoMintz NFTs Sweepstakes

Official Rules

**No Purchase Necessary To Enter or Win.
Purchasing Will Not Increase Your Chances of Winning.**

1. SWEEPSTAKES TIMING: The **AUDL MoMintz NFTs Sweepstakes** (the “**Sweepstakes**”) starts Tuesday, September 6, 2022 at 9:00 a.m. Eastern Time (“**ET**”) and ends on Saturday, December 31, 2022 at 11:59:59 p.m. ET or when 1,000 AUDL MoMintz packs have been sold, whichever occurs first (the “**Sweepstakes Period**”).

2. ELIGIBILITY: The Sweepstakes is open to legal residents of the U.S. and the District of Columbia and Canada (excluding residents of Quebec), eighteen years of age or age of majority in the jurisdiction of their residence, or older at the time of entry. Employees of Ultimate Disc League, LLC (“**Sponsor**”, “**AUDL**”, “**we**”, or “**us**”), the Cohen-Friedberg Associates, LLC (“**Administrator**”) (collectively, the “**Sweepstakes Entities**”), and their respective parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate families (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to win. The Sweepstakes is subject to all applicable federal, provincial, state and local laws.

4. HOW TO ENTER:

1. The first way to enter the Sweepstakes and obtain one (1) Official Entry is to purchase one (1) or more AUDL 2022 MoMintz Series Packs during the Sweepstakes Period. Don't have an account? It's FREE to register. Create an account by visiting <https://audlmomintz.com> and following the prompts. Once an account has been created you may begin to purchase AUDL 2022 MoMintz Series Packs and be entered into the Sweepstakes.

2. **Alternate, No Purchase Necessary Official Entry:** To receive one (1) Official Entry into the Sweepstakes without purchasing AUDL 2022 MoMintz Series Packs (as listed in 1. above) handwrite the name of this Sweepstakes, your first and last name, street address, city, state, zip/postal code, daytime telephone number (including area code), email address where you can be contacted, and year of birth on a plain 3” x 5” piece of paper and mail the entry in a properly stamped envelope to AUDL MoMintz NFTs Sweepstakes,

Five (5) potential prize winners will be selected by the Sponsor in a random drawing from among all eligible entries received during the Sweepstakes Period.

6. WINNER NOTIFICATION: Each potential prize winner will be notified by email. The potential prize winner must then respond to Sponsor within two (2) business days to acknowledge receipt of the notification and to reply with answers to any questions. The inability to contact, or receive a response from, a potential winner through email may result in disqualification and, at Sponsor's discretion, the awarding of the applicable Prize to an alternate potential winner in a random drawing from among all remaining entries for the drawing at issue. The Released Parties (defined below) are not responsible for any delay or failure for a potential winner to receive notification from Sponsor, or for Sponsor to fail to receive a potential winner's response, for any reason, including inactive account(s), technical difficulties associated therewith, or a potential winner's failure to adequately monitor any account. MODIFICATION /FORCE MAJEURE: In the event (a) an insufficient number of Eligible Entries are received, (b) a virus, bugs, or entrant fraud or misconduct affect or corrupt the administration, integrity, security or proper operation of the Sweepstakes, (c) Sponsor deems necessary in order to comply with the terms of use or terms of service of any applicable social media platform or in connection with changes to such terms, or (d) Sponsor is prevented from awarding the Prize or continuing with the Sweepstakes as contemplated herein by any event beyond his control, including but not limited to, fire, flood, natural or man-made epidemic of health of other means, pandemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis (e.g. SARS), pandemic, order of any court or jurisdiction, or
